We will make an appointment for on-site submission at the Consulate as soon as we receive an application and all documents from you.

Applicants must refer to the '[Important Tips for online COVA visa form filling](#)', to ensure the COVA forms are true, accurate, and complete. Once the COVA form is submitted, no information can be changed. If any adjustment needs to be made, the whole COVA form must be filled out again.

After completing the COVA forms as required, please make sure to print the full set of COVA forms (8-9 pages) and sign on the Confirmation Page and the 8th page. If the COVA forms are not prepared as guided, the application will not be accepted.
